



Notice on the Announcement of the Election of a Candidate to the Office of Dean of the Faculty of Security Engineering of the University of Žilina

Pursuant to Section 13d of the Statute of the University of Žilina (hereinafter the „UNIZA Statute“), the Chair of the Academic Senate of FSE (hereinafter the „AS FSE UNIZA“), following approval by the electoral assembly,

hereby announces the election of a candidate to the office of Dean of the Faculty of Security Engineering of the University of Žilina.

Pursuant to Section 22(2) of Act No. 131/2002 Coll. on Higher Education Institutions and on the amendment of certain acts, as amended, and Section 13d of the UNIZA Statute, the Dean is elected by the electoral assembly, which is composed of: a) representatives of the academic community of the faculty and b) persons appointed by the Rector in a number corresponding to $\frac{1}{4}$ of the total number of members of the electoral assembly. For the purposes of the electoral assembly, the representatives of the academic community of the faculty are the members of the AS FSE UNIZA. The entire process of filling the office of Dean by election is governed by Section 13d of the UNIZA Statute.

The right to nominate a candidate for the office of Dean of FSE is held by members of the academic community of FSE and UNIZA (individuals or groups) within the period set out in the election schedule. A nomination may contain no more than one candidate for the office of Dean.

Nominations for the inclusion of a candidate for the office of Dean on the list of candidates shall be submitted in writing to a member of the election committee in a sealed envelope marked „Nomination of a candidate for the office of Dean of FSE UNIZA“.

The nomination must state the name, surname and academic titles of the candidate for the office of Dean, and the name, surname, academic titles, date and signature of the nominator(s). **Nominations of a candidate for the office of Dean may be submitted to a member of the election committee in person, via the UNIZA registry office, or by post.** In the case of personal delivery and submission of the nomination at the registry office, the date of receipt is decisive, and in the case of sending the nomination by post, the nomination must be delivered to the University before the expiry of the deadline for submitting nominations. The member of the election committee is obliged to inform the Chair of the electoral assembly electronically of the receipt of a nomination. Nominations delivered after the deadline shall not be taken into account.
